She was born February 24, 1868 in Clay County Illinois, and died December 23, 1949 in Clay County Illinois. She was the daughter of Andrew Jackson Pridemore and Easter Clarinda Turner. He married (2) **Ella Farnsworth** November 02, 1921 in Probably Clay County Illinois. He married (3) **Ida Josephine Rogers** January 1936 in Clay County Illinois. She was born February 24, 1868 in Clay County Illinois, and died December 23, 1949 in Clay County Illinois.

2. **Joshua Wesley Rogers**, born September 19, 1836 in Clay County Illinois; died February 16, 1876 in Clay County Illinois. He was the son of 4. **Thomas Rogers** and 5. **Charlotte Pugh**. He married 3. **Rachael Emmiline Winchester** May 12, 1858 in Clay County Illinois.

3. **Rachael Emmiline Winchester**, born March 25, 1835 in N C; died January 25, 1908 in Clay County Illinois. She was the daughter of 6. **Jason Winchester** and 7. **Martha Mattie Mae Helm**.

Notes for Joshua Wesley Rogers:

Sued his brother Andrew Jackson James Rodgers for the return of a "rifle with brass butt", their father Thomas testified for J. Wesley, and won the case.
buried Rogers Family Cemetery Larkinsburg Twp. Clay County Illinois
Wesley did not serve in Civil War as did his brothers Wm. Noah and Andrew Jackson James Rodgers.
birth year may have been 1835

her daughter is Emmiline Rachael, "Emma R. " Rodgers" Taylor, Denton

Death certificate: name is Emma Killingsworth, she was widow of John
they both had several children when they married later in life - no children together
